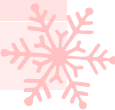

<b>Pajamas/Sleepwear</b>	Pajamas, Footie PJs, Robes
<b>Dresses/Skirts</b>	Fall/Winter Dresses & Skirts
<b>Onesies (0-24M Only)</b>	Onesies and Rompers - Long Sleeve & Pant Onesie without Footies
<b>Tops</b>	Long Sleeve Tees, Cardigans, Button Downs, Polos, Sweaters, Hoodies/Pullover/Zip Sweatshirts
<b>Bottoms</b>	Pants, Leggings, Overalls
<b>Sets</b>	A Top & Bottom sold together as an outfit, etc.

#### 20 TAG LIMIT PER GENDER

You may bring up to 40 tags of teen clothing per sale. This means:

- Up to 20 tags of clothing designated for the girls section
- AND up to 20 tags of clothing designated for the boys section

**ALL CONSIGNORS** – including Perfect Consignors, Power Consignors, or Consignors that utilize a valet tagger outside of JBF must have their teen clothing inspected. The Drop off Guide will have more information regarding teen clothing inspection

We will **NOT ACCEPT** clothing designed and marketed for adult Women or adult Men

**Just because your teen wore it, does not mean that JBF will automatically accept it for resale**

#### SEASONAL GUIDELINES STILL APPLY!

Do not bring shorts to the Fall sale or fleece in the Spring!

#### When CREATING TAGS for clothing in teen sizes, ALWAYS...

- Select the category of "clothing-teen"
- The size category should be 16, 18, XS, S, M, or L
- Add size and description in the description box, like shown

### DISCLAIMER

The brands on the above Do Not Accept List are firm guidelines - We don't accept brands from general merchandise/big box stores (Target, Kohls, Walmart) in any of our teen clothing sizes and we don't accept brands geared towards just adults, either. We want name-brand clothing tweens/teens will wear!

Prom Dresses and Scrubs are also a No Thank You

**\*\* Brands/items that are not on the Teen No Thank You List but are clearly adult brands and adult styles will not be accepted under the sole discretion of the inspection Team \*\***



To Check your items for recalls, visit <https://www.cpsc.gov>

Ensure that ALL pieces and parts are present and ALL safety straps are included

**Keep in mind the 4 C's:** All items should be Clean, Current, Complete, and Compliant  
**All items MUST have working batteries**

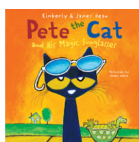

# WHAT GETS A Yellow Tag

Go to <https://www.cpsc.gov> to check your items for recalls  
**ALL items must meet safety standards, all straps must be included**



All items that plug in **AND** take batteries (swings, etc.) **MUST** have working batteries

## HOW TO DROP OFF A YELLOW TICKET ITEM:

1

All items that require a yellow tag are to be brought to the big ticket drop off area located on the consignor drop off map.

2

All items must be assembled by the seller at drop off.

3

JBF will sanitize items as required and provide the seller with a yellow ticket.

4

The seller will staple their white JBF tag to the yellow ticket, and attach the yellow ticket to their item(s).

### CAR SEATS AND BASES MUST:

- Have 1 full year of use prior to the expiration date
- Include a signed car seat waiver, the instruction manual & be free of recalls

### CRIBS MUST:

- Be manufactured within 5 years of the event date and have had zero recalls
- Include a signed crib waiver, the instruction manual, and be free of recalls

**Train Tables and Large Furniture**  
(cribs, toddler beds, dressers, etc.)



Are accepted, but the seller **CANNOT** mark them for donation, and **MUST** pick them up if they do not sell.

I verify that the car seat has not been recalled to the best of my knowledge and if so, has been corrected to meet Motor Vehicle Safety standards. I verify that the car seat has all its harness straps, harness clip, seat cover, padding, shield and bolts and that the locking mechanism locks securely.
